

### BACKGROUND

As the White Ribbon Alliance Global Secretariat concludes in 2024, its assets have been transitioned to the <u>World We Want Project</u> to support global health and development. This project is now led by the Global Office Consulting (Comotion Social Change Agency -COMO) and the Forum for Women's Development and Research (FWDR). The WWW project initiative has planned quarterly AskForce meetings from 2024 to 2026 to discuss strategies to promote the WWW mission.

The second Askforce meeting, virtually held on October 24, marked the final meeting for 2024. The purpose of this meeting was to expand on the foundational objectives set during the inaugural gathering. It primarily focused on further introducing the Askforce members, including new participants like Mr. Hafizuddin Faqiree from WRA Afghanistan, to the WWW mission and presenting an updated roadmap made by FWDR.



# **OBJECTIVES**

### The objectives for the second Askforce meeting were as follows:

- 1) To learn about FWDR's progress related to the WWW movement.
- 2) To hear about the International Childbirth Initiative.
- 3) To understand the significance of community health workers.
- 4) To recognize the demands that girls have for a better future.

The meeting began with a warm welcome from Dr. Amanullah, CEO of FWDR/WRAP. He expressed his gratitude to everyone for their participation and outlined the meeting's objectives. Dr. Amanullah extended a special welcome and thanks to the representatives from the International Childbirth Initiative and WRA Afghanistan. He emphasized FWDR/WRAP's commitment to sustaining the legacy of the White Ribbon Alliance movement through the World We Want project.

Following the welcome note, Javaria Nisar provided an update on the World We Want project on behalf of FWDR/WRAP. She introduced the updated Askforce Members Directory, designed to enhance collaboration among members. Javaria shared that efforts are underway to amplify members' contributions through social media, aiming to boost global engagement and visibility. Members were encouraged to share their achievements and stories across all available communication channels.

She also highlighted that they are in the final stages of developing a self-learning module based on the Ask, Listen, and Act methodology, with plans for a complementary video tutorial. Additionally, a new communication strategy focused on advocacy is being developed to keep members informed and expand outreach. FWDR is also making progress toward formal registration in a third country, which will facilitate sub-granting for member initiatives. By the end of the year, FWDR will take on responsibility for managing WRA's global websites.

Dr. André Lalonde, Chair of the International Childbirth Initiative (ICI), presented an overview of the initiative, which advocates a comprehensive framework for promoting safe, respectful, and supportive maternity care worldwide. With the endorsement of over 35 partner organizations, ICI invites all maternity facilities committed to its standards to join the movement.

The ICI framework emphasizes essential core values that foster a maternity care system prioritizing respect, safety, and effectiveness, addressing the needs of mothers, babies, and families—collectively known as the Mother-Baby-Family triad. Designed to be adaptable across diverse health facilities globally, the initiative includes components such as self-evaluation, goal-setting, and community involvement to drive continuous improvements in care quality. Furthermore, ICI serves as a global knowledge-sharing network, providing resources and support to participating facilities.

Then the discussion, led by Sarah Hinton, Executive Director of the Global Midwife Education Foundation (GMEF), focused on the interconnectedness of health and essential resources, emphasizing the Foundation's efforts to improve community health by addressing root causes such as access to clean water and sanitation, particularly in rural Bolivia, where maternal and infant mortality rates are high.

GMEF identified a community demand for locally based health support, leading to the development of the promotora (community health worker) program. This program trains selected local women to serve as health resources within their communities. Healthcare professionals from local health centers facilitate meetings with promotoras regularly over a three-year period, ensuring that even communities with limited access to health centers receive ongoing health education and support.

The presentation, conducted by Tammy Tibbets, Co-Founder and CEO of She's the First, centered around the initiatives of She's the First, particularly focusing on empowering girls in the Global South through education about sexual health, reproductive rights, and girl-led activism. Tammy highlighted two main programming pillars: a card game designed to facilitate conversations about sexual education among girls and girl-led activism through local chapters.

Tammy informed us that the card game was introduced as a tool for girls to discuss sexual health and reproductive rights in a supportive environment. Mentors facilitate discussions that help identify misunderstandings or myths about bodies, relationships, and consent among girls, allowing for targeted follow-up sessions.

She also underscored that nearly 200 girl-led chapters globally teach girls about their rights and activism. An 18-month fellowship program connects diverse girls, helping them understand the systemic issues they face. She informed us that a Malaysian fellow's group created a children's book addressing consent and safe touch, which was shared in their communities and translated into multiple languages.

The Questions & Answers session emphasized the importance of having males as allies. Dr. Andre Lalonde talked about involving fathers in childbirth, noting that when fathers participate, they are more likely to engage in raising and protecting their children. This involvement is seen as crucial for making positive changes for girls and women globally.

Then, Sarah Hinton highlighted the role of promotoras in rural communities, who actively engaged the entire community, including male leaders, by presenting health topics and ideas at town hall meetings. This strategy was effective in fostering male involvement in community health initiatives.

Askforce members particularly expressed interest in collaborating with 'She is the First,' especially in Uganda. The meeting concluded with gratitude towards the presenters and participants, reinforcing the value of the discussions.

The optional session, facilitated by Ferdinent M. Sonyuy, Community Development Advocate at the Reconciliation & Development Association, focused on preparing a collaborative application for a significant global grant opportunity from Melinda French through *Lever for Change*. This grant aims to support organizations dedicated to women's mental and physical health, as well as gender equality.

Key points from the Request for Proposals (RFP) were discussed:

- The total grant amount is approximately \$250 million, with a submission deadline set for January 2025.
- Participants agreed to consider submitting a joint proposal under the "AskForce" umbrella to enhance the application's strength.
- Organizations were encouraged to research their country's legal frameworks regarding sub-granting and to collaborate accordingly.
- Ferdinent was assigned the task of identifying interested organizations for the consortium and coordinating the effort.
- FWDR/WRAP expressed their inability to participate in the bid; however, they ensured their support in reviewing the proposal and any other assistance required.

# The International Childbirth Initiative

ICI provides a framework for implementation of safe and respectful care practices and policies, the 12 Steps for Safe and Respectful MotherBaby-Family Maternity Care. It is implemented through individual health facilities, through self-evaluation, goal-setting, and community participation.

ICI provides a global resource network striving to share learning and improve the provision of care.

- ICI was created by International Federation of Gynecology and Obstetrics, the International MotherBaby Childbirth Organization, ICM, IPA, and White Ribbon Alliance
- ICI is endorsed by >35 partner organizations and growing.
- Open to all birthing facilities who are willing to commit to delivering safe and respectful MotherBaby-Family Maternity Care.





### Foundational Principles

- Ensure respectful maternity care
- Protect the MotherBaby-Family triad
- Promote wellness, prevent illness and complications, and ensure timely emergency care
- Support women's autonomy and choices to facilitate a positive birthing experience
- Provide a healthy and positive birthing environment as a responsibility of caregivers
- Use an evidence-value-and competency based approach to service provision incorporated into the MotherBaby-Family model of care

#### World We Want



Treat every woman and newborn with compassion, respect and dignity, without physical, verbal or emotional abuse, providing culturally safe and culturally sensitive care that respects the individual's customs, values, and rights to self-expression. Provide informed choice and privacy.

Respect every woman's right to access and receive non-discriminatory and free or at least affordable care throughout the continuum of childbearing, with the understanding that under no circumstances can a woman or baby be refused care or detained after birth for lack of payment.

Routinely provide MotherBaby-Family maternity care. Incorporate value- and partnership-based care grounded in evidence-based practice and driven by health needs and expectations as well as by health outcomes and cost effectiveness. Base care provision on what women want for their newborns and families. Optimize the normal bio-psycho-social processes of childbirth by promoting the midwifery philosophy and scope of practice for most women.

Acknowledge the mother's right to continuous support during labour and birth and inform her of its benefits, and ensure that she receives such support from providers and companions of her choice.

Offer non-pharmacological comfort and pain relief measures during labour as safe first options. If pharmacological pain relief options are available and requested, explain their benefits and risks.

Provide evidence-based practices beneficial for the MotherBaby-Family throughout the entire childbearing continuum.

#### World We Want



Avoid potentially harmful procedures and practices that have insufficient evidence of benefit outweighing risk for routine or frequent use in normal pregnancy, labour, birth, and the post-partum and neonatal period.

Step 8 Implement measures that enhance wellness and prevent illness for the MotherBaby-Family, including good nutrition, clean water, sanitation, hygiene, family planning, disease and complications prevention and pre-and-post natal education.

Provide appropriate emergency obstetric and neonatal treatment when needed. Ensure that staff are trained in recognizing (potentially) dangerous conditions and complications and in providing effective treatment or stabilization, and have established links for consultation and a safe and effective referral system.

Step 10 Have a supportive human resource policy in place for recruitment and retention of dedicated staff, and ensure that staff are safe, secure, respected and enabled to provide good quality, collaborative, personalized care to women and newborns in a positive working environment.

Provide a continuum of collaborative care with all relevant health care providers, institutions, and organizations with established plans and logistics for communication, consultation and referral between all levels of care.

Promote breastfeeding and skin-to-skin contact, refer to the 10 Steps of the Baby-Friendly Hospital Initiative and integrate into practice, training, and policies.

### Join ICI

- The first step for a facility to join ICI is to create a committee that brings together the professions: midwives, nurses, OB/GYNs, pediatricians.
- Psychologists, social workers, administrators, doulas, community health workers should also be considered for inclusion.
- At least one women's representative from a local, regional, or national women's organization should be included.
- Members of this committee then complete an application, available here: IClchildbirth.org/application

- Each hospital administers Women's and Companion's questionnaires as a tool to give insight into a facilities' strengths and areas for potential improvement.
- Questionnaires are administered throughout the year, to sample a representative number based on delivery volume
- Questionnaires are available in 17 languages







- Disrespectful care is an issue around the world; ICI provides a framework for healthcare providers to come together and address sources of disrespect.
- Women should be at the center of decisions regarding their labour and delivery
- Until you survey women, you cannot evaluate or understand if you are maintaining a respectful environment for maternity care
- Promotion of physiological birth does not pose a barrier to providing safe births.
- ICI is a holistic program for safe respectful birth





# **Outcomes**

- Anchored supplies and knowledge in the rural communities
- Promotoras became eyes and ears for the communities
- Built connections and trust between communities and health system
- Women are empowered to take leadership roles in their community
- Girls have a trusted source for information about topics that may be difficult to discuss with a man or health care professional they don't know (birth control, sexual health, puberty)





# AN UNEXPECTED OUTCOME A SENSE OF PURPOSE

When asked if they would recommend this program for other communities 100% of participants said yes.



"Yes, because with this program we learn how to save ourselves."



"Yes, the program it is a great strength for the community and health personnel."



"Yes, we would recommend it to all departments."

#### WHAT THE HEALTHCARE WORKERS ARE SAYING

- "We've seen big changes, most of all in more women getting prenatal care."
- "There is more knowledge about health issues in the community because the promotoras share their knowledge with the community."
- "This program has been a great support and good for the communities. It helps us provide care in time."
- "This has supported very much in our area of Totora and thanks to that, we have reduced maternal mortalities and deaths from respiratory infections and diarrhea."
- "We've seen an increased interest in the communities around the importance of promoting health."

# What the Promotoras Are Saying

- "The community was happy that I was becoming a Promotora and started asking me about their children's illnesses."
- "Our communities supported this program. My family and my whole town supported me in becoming a Promotora."



What the Communities are Saying "Now we have a trusted person of the community to guide us on health issues."

"Now we have someone to consult about health problems when there aren't any medical providers available." "Now we have a resource within our own community"

"I was pregnant, I was afraid to go to the health post for checkups. I told the Promotora and she explained to me the importance of prenatal check-ups and even went with to my visits!"

# By the Numbers

Double the number of prenatal appointments attended by women

More than 75% reduction in unwanted pregnancies

More than 30% increase in birth control use

Dramatic decrease in the number of severely ill babies

More than 400% increase in women getting cervical cancer screening

Numerous communities have expressed interest in participating in this program.

In September 2024 we launched the next two cohorts in the Sacaca and Tinguipaya regions and have several more lined up to begin in 2025.
